Using Technology for Interpretation

Indiana and Kentucky took different paths when using new media and technology to introduce their visitors to different aspects of their state parks. At both sites the personal communication device augments the educational/interpretation function of paid staff that cannot be on site at all times.

Popular programs like school history kits, topical highlights, and oral history programs have been revamped to be more responsive, more collaborative, and to feature on-demand options. As the world changes at an ever-increasing pace, the City Museum has looked to new ways to offer time-tested programs to better reach audiences and to raise aware ness about the museum's resources.

Legal Obligations of Donors and Museums

This session will review the various ways in which a museum may become liable for unexpected costs and expenses related to museum exhibits and what actions museum may take to avoid such liability. It will also include a discussion on legal restrictions and obligations that may attach to a donation, with some real life examples of where gift recipients went wrong.

University Students, an Historic Site, & Funding, What Else is Needed for a Successful Collaboration?

Join Northern Illinois University Museum Studies instructors and alumni for a discussion of a three-year exhibit project at a local site, the Ellwood House Museum. Learn about the student involvement, project coordination, and

the funding and evaluation processes. This session will focus on the steps taken to give a meaningful experience to students and to create a significant exhibit to share with the museum's visitors.

Enjoy an evening of music, art, science, and good food at the Illinois State Museum while you experience the art and culture of Illinois. Spend the evening creating an art project or doing a fun science activity while enjoying some great music from Shay on Sax and a cold drink. Explore the award winning *Changes* exhibition dealing with the Illinois environment from our days as a swamp to the ice age to the present, all based on the research of Museum staff.

Alternate location will be the Dana Thomas House, a Frank Lloyd Wright masterpiece.

7:30 pm Lincoln Ghost Walk or Prohibition History Pub Crawl

The **Lincoln Ghost Walk** is a 90-minute walking tour that uses the Lincoln sites as the backdrop for strange and bizarre stories surrounding Lincoln's life and death. What were Lincoln's spiritual and Christian beliefs, and did he have bizarre visions and dreams of death? Mary believed in Spiritualism and had séances in the White House. We'll also talk about his funeral train and the opening and movements of Lincoln's coffin through the years until finding his final resting place in 1901. This is largely a factual history tour including the known ghostly lore.

The **Bootleggin' Prohibition Pub Crawl** walking tour is a 2-3 hour caper, your guide will take you to 3-4 establishments within the Old Town District and tell you of Springfield's wicked Prohibition history at each location. You'll hear amusing stories of blind pigs and raids on stills, as well as murderous stories of sidewalk assassinations. Did Springfield have a crime boss? Yes we did, come along, we'll tell you about it - this is the Bootleggin' Pub Crawl! Do it, or else!

Basics of Archives

Elaine Evans, Senior Archivist, and Catheryne Popovitch, Records Archivist, Illinois State Archives
The Basics of Archives is designed to give organizations and individuals who are responsible for the care of historical records an introduction to the core aspects of managing and protecting historical records collections, using appropriate principles and best practices.

Collateral Damage: Are You Causing Damage to Your Institution's Collections?

Based on the Heritage Health Index (HHI) from 2004, 65 percent of museums are causing irreparable damage to their collections. The HHI study recommends that museum professionals obtain hands-on training to gain knowledge in best practices in collections care. This session will discuss the benefits of applied collections care training to protect collections in your care from damage.

The Basics of Public Policy Relationships (Who, What, When, Where, and How of Advocacy)

"Museum closing proposed in light of budget issues." There was a time, not too long ago, when the only time a museum contacted an elected official was to ask about a government grant deadline. Now, understanding public policy and establishing relationships with your elected officials is more important than ever. This session provides a chance to review the Ws and one H of museum advocacy. Bring your questions and suggestions.

Get it In Writing: Creating a Code of Conduct/Preventing Internal Theft

Museums takes steps to prevent theft by the public from our exhibitions, but the majority of thefts from collections are made by staff. Learn how to protect your collections from internal theft and how to create a code of conduct or code of ethics that guides staff, trustees, and volunteers on ethical and legal behavior.

Luncheon and Speaker

Join us for lunch and a presentation by Theodore J. Karamanski on his new book *Civil War Chicago: Eyewitness to History* sponsored by the Historic Preservation Agency and the Abraham Lincoln Presidential Library and Museum. The American Civil War was a crucial event in the development of Chicago as the metropolis of the heartland. Not only did Chicagoans play an important role in the politics of the conflict, encouraging emancipation and promoting a "hard war" policy against Southern civilians, but they supported the troops materially through production of military supplies and foodstuffs as well as morally and spiritually through patriotic publications and songs. Karamanski is a professor of history at Loyola University Chicago, where he founded and directs the Public History Program. He is the author of seven books, including *Rally 'Round the Flag: Chicago and the Civil War, Schooner Passage: Sailing Ships and the Lake Michigan Frontier*, and most recently *Blackbird's Song: Andrew J. Blackbird and the Odawa People*.

1:45 - 3:15 pm

The New Face of AAM Accreditation

Dr. Bonnie Styles, Illinois State Museum System

This session will focus on the recent changes to the American Alliance of Museum's Accreditation program. The changes have streamlined the process and made accreditation more attainable.

Visitor Services (Be a Hedgehog, not a Fox about Visitor Services)

Kate Neumiller Schureman, VP of Administration/COO, Peoria Riverfront Museum

Taken from the poetry of the ancient Greek Archilochus, "A fox knows many things, but a hedgehog one important thing." More and more museums are understanding the need to become more visitor-focused. This session will review why visitor services are so important and provide some not so expensive tools to improve visitor services. Learn how to be a hedgehog when it comes to visitor services in your museum.

TOUR - Hoogland Center for the Arts

The Hoogland Center for the Arts, a nonprofit organization, opened in 2004 as a community arts center in the historic downtown district. A former Masonic Temple, the 80,000 square foot facility, was purchased and donated by two private citizens. After receiving an Illinois Arts Council grant for planning and architectural consulting it was given a \$7.5M renovation thru a State of Illinois grant and a community capitol campaign. Today the multipurpose facility includes a 350 seat theater, several smaller performance stages, meeting/conference rooms, and an Art Gallery and school. The facility also hosts eighteen arts and community organizations. Now in its 11th year of operation the Center continues to be an important local and central Illinois cultural hub and destination. Participants will also have the opportunity to shop at the Prairie Arts Alliance store inside the Center!

TOUR - Springfield Historic Sites Tour

Take a walking tour of the historic homes of Springfield including the Old State Capitol, Dana-Thomas House, and the Iles House! The Old State Capitol is a reconstruction of Illinois' fifth statehouse, the first to be located in Springfield. The building served as the seat of state government and a center of Illinois political life from 1839 to 1876. The Dana-Thomas House, perhaps the best-preserved example of famed architect Frank Lloyd Wright's Prairie style dwellings, was built for feminist socialite and heiress Susan Lawrence Dana (1862-1946). Constructed between 1902 and 1904, the spectacular brick house covers 12,600 square feet, with thirty-five rooms and sixteen major spaces. The house contains more than 100 pieces of original Wright furniture, 250 examples of art glass doors and windows, and more than 100 art glass light fixtures. The Iles House is the oldest house in Springfield and has its original siding, interior wood work, hardware, flooring and walls. Abraham Lincoln was a frequent visitor when his friend Robert Irwin owned the home. The house was home to State Senator Elijah Iles and Illinois Governor Shelby Cullom.


